



## Consent Form for Minor Participants at the Zurich Model United Nations Conference 2025

As the legal guardian, I hereby provide my consent for my child to participate in the Zürich Model United Nations Conference, scheduled to take place from April 11th to 13th, hereafter referred to as ZuMUN. I affirm that I have understood the terms and conditions of the event and agree to them, particularly regarding the following points:

- 1. Minimum Age:** I confirm that my child is at least 13 years old.
- 2. Alcohol Consumption:** I am aware that alcoholic beverages will be available during the ZuMUN Socials. I understand and agree that the sale or consumption of alcohol by persons under the age of 18 is strictly prohibited and that this rule will be rigorously enforced.
- 3. Supervision after 9PM:** According to youth protection regulations<sup>1</sup> minors under the age of 16 must be accompanied by an adult after 9PM. I confirm that in these instances my child will be accompanied by a designated Faculty Advisor or another adult specified by me.
